1. The term commercial shall apply to any and all events for which an admission is charged for "private gain."
2. At least one cook must be employed if the kitchen is used, and the user will reimburse the school the actual amount paid the cook. Any overtime paid to employees is at the rate of time and-a-half.
3. Through arrangements made with the Rolla Park Board, the school charges \$10.00-\$20.00 (new) per night for the adult activities held in the gymnasiums.
4. If an organization is sponsoring an activity that is judged to be beneficial to a number of Rolla Public School students, that organization will be charged only the actual increased cost the district incurs.
5. Groups that wish to utilize the stage lights in the middle school auditorium shall be assessed an
additional fee of $\$ 30.00$ per hour.
